Abstract. Selondang Kelapa Market is the main market in Tembilahan City, the fire incident in 2019 caused this market lose its vital function. The of the Selondang Kelapa Market aims to re-optimize the function of the market as before and develop it into a market with modern buildings and as regional tourism destination. The application of Tembilahan's local potential and the Neo-Vernacular Architecture theme to buildings is expected to make the Selondang Kelapa Floating Market a city icon and landmark in Tembilahan City.

INTRODUCTION

According to the Kamus Besar Bahasa Indonesia (KBBI), a market is a place where people carry out buying and selling activities in the form of goods and services. Apart from being a place buying and selling activities take place, the market is the identity of a region/city. When The market in an area is in good condition, so the regional identity is good too.

Tembilahan City is the capital of Indragiri Hilir Regency, Riau. City Tembilahan has a main market, known as the Selondang Kelapa Floating Market, because it is located on the banks of the Indragiri river.

Tembilahan, the capital of Indragiri Hilir Regency, is well-known for its rich cultural and economic potential, particularly in the coconut industry. As part of the region's development plan, the local government has sought to capitalize on this potential by designing the Selondang Kelapa Floating Market. This initiative is aimed at promoting the city's unique identity while bolstering the local economy through the revitalization of traditional markets. Pasar rakyat, or public markets, have long played a crucial role in Indonesia's economic structure, providing accessible marketplaces for daily necessities and fostering social interaction. According to the National Standardization Agency (Badan Standardisasi Nasional, 2015), public markets must meet specific quality standards to ensure they effectively serve their communities and contribute to the local economy.

The Selondang Kelapa Floating Market project aligns with broader urban planning efforts in Tembilahan, particularly the development of the Water Front City area, which spans

from Parit 11 to Parit 15. This initiative is governed by the Indragiri Hilir Regency's 2016 Regulation No. 8 concerning building and environmental planning in the area (Peraturan Bupati Indragiri Hilir, 2016). By leveraging the city's natural waterways, the floating market is designed to serve as both an economic hub and a tourist attraction, drawing visitors while enhancing the livelihoods of local traders.

In terms of market regulation, the design and management of Selondang Kelapa Floating Market adheres to national guidelines established by the Ministry of Trade's Regulation No. 70 of 2013 on the development of traditional markets, shopping centers, and modern stores (Republik Indonesia, 2013). These regulations emphasize the importance of maintaining traditional market spaces while ensuring they remain competitive with modern retail outlets. The floating market concept offers a distinct advantage, integrating the region's natural resources and cultural heritage with modern market management practices.

Additionally, Tembilahan's development as a floating market hub reflects the region's economic priorities as outlined in earlier legislation, including the 2005 Regional Regulation No. 28 of Indragiri Hilir Regency, which supports local economic development through strategic planning initiatives (Republik Indonesia, 2005). The market will not only enhance the city's economy but also serve as a symbol of Tembilahan's connection to its waterways and agricultural potential, specifically its iconic coconut industry.

In summary, the creation of the Selondang Kelapa Floating Market taps into the unique local potential of Tembilahan, combining traditional market practices with modern urban development strategies. By incorporating local cultural elements and natural resources, the market aims to become an icon of the city, strengthening its identity and fostering sustainable economic growth.

On August 22 2019, the Floating Market experienced a fire. The current condition of the Floating Market is that it has been permanently closed by the local government. The physical condition of the building has been destroyed in the walls, roof and floors. Wall which was blackened due to fire, the floor had collapsed into the river, and the existing condition buildings that can no longer be used. Because market conditions are not allows it to be utilized by traders who previously sold in the market, now selling in tents set up in the circulation on Jalan Yos Sudarso. These merchant tents cause another problem, namely hampering circulation at the moment market conditions are busy with visitors, road circulation must be shared with tents/lots traders, visitors on foot, passing vehicles, parking lots on the shoulder of the road, as

well as rickshaws and motorbike taxis hanging out on the shoulder of the road. A number of it is the existing problems that are expected to be resolved by designing back to the Selondang Kelapa Market area. It is hoped that with the design Selondang Kelapa Tembilahan Floating Market area, this area can return to become one of the icons of Tembilahan City.

The application of the Neo-Vernacular Architecture theme is expected to support function The Floating Market is an icon in Tembilahan City, and is a characteristic of the City Tembilahan. We hope to get a modern impression and a touch of local Melayu culture supports this function.

LITERATURE REVIEW

2.1 Location

The zoning function of the Selondang Kelapa Floating Market area according to the Regional Spatial Plan Riau Province is included in an area with trade and commercial zone functions. Whereas according to the Bappeda of Indragiri Hilir Regency, the site of the Selondang Kelapa Floating Market area itself included in zone D. Zone D is dominated by trade and services, image of Zone D can be seen in image 2.1.

The average intensity for trade and services and other facilities is, KDB (Basic Coefficient Building) the maximum permitted is 60-70%, the maximum KLB (Building Floor Coefficient) is 2.4 with the maximum permitted building height being 4 floors, KDH (Basic Coefficient Green) is a minimum of 30% of the area. The orientation of buildings in zone D must be oriented towards Jalan Jendral Sudirman and the Indragiri River. Application of GSB

(Border Line Building) is by applying the formula ($ROWx\frac{1}{2}$) measured from the outside of the Road Owned Space (Ruminja).

2.2 Theme

Riau Province itself is an area with a majority population Melayu tribe. Melayu Riau architecture is one style traditional architecture in the Riau area which is dominated by Melayu community, which reflects the characteristics of the traditional values adhered to by the Melayu Riau community.

The implementation can be:

- a) Application of Melayu Riau architectural elements: roof, door, window, and ornamens.
- b) Use of colours of Riau Melayu architectural
- c) Use of ornamens of Riau Melayu architectural

METHOD

The research method begins with researching existing field conditions, both the location of the old Selondang Kelapa market, as well as researching the potential of the local area which will be applied to the design planning for the Selondang Kelapa Tembiahan market area. Then, the research continued by planning the concepts that would be applied based on the results of research on existing conditions in the field. The research results and design strategies are used as a basis for implementing design strategies in the spatial program design, zoning, mass transformation and final building design.

RESULT AND DISCUSSION

- 4.2 Design Analysis
- a) Location

The project is located on Jl. Kol. Yos Sudarso, Tembilahan, Indragiri Hilir, Riau, with land use dominated by comercil area with wide area of \pm 4Ha. The existing location of the site can be seen in image 4.2.1.

on the site, analysis of accessibility to the site, analysis of views around the site, and analysis of climate and noise around the site. The design analysis can be seen in Table 6.





4.3 Design Results


